The library will close at 1:00pm on December 24th. All full-time staff are expected to work 4.5 hours on the day or use vacation, comp, or floating time. Staff not scheduled to work that day will not accrue comp time.

If a holiday falls on a Saturday when the Library is closed, any benefit-eligible employee not scheduled to work that day shall receive 7.5 hours of compensatory time or equal pay for the day at their option as per the CSEA contract.

The library will be closed to the public on Monday June 22, 2025 and Monday October 12, 2025 (Columbus/Indigenous Peoples' Day) for staff training. All staff are expected to report to work at 8:30am and will be paid for a full day of work, including any part-time staff who are able to attend.

The library will be closed to the public at 1:00pm on Friday December 18th for a staff holiday party. To receive pay for a full day, staff will be expected to stay for the full holiday party or use vacation, comp, or floating time.



SCHOOL OF SOCIAL WORK LIBRARY FIELD EDUCATION AFFILIATION AGREEMENT

TERM AND TERMINATION

(a)This Agreement shall commence January, 2026_ and the term shall be one academic year. Thereafter, this agreement shall automatically renew from year to year unless terminated at the end of any contract year, as set forth in paragraph "(b)" below.

(b) Either party may terminate this agreement on written notification which shall be made at least one semester prior to its scheduled termination date. For the purposes of this agreement the academic year begins on September 1st and ends August 31st.

A. ADELPHI UNIVERSITY AGREES:

- 1. To assume responsibility for planning, directing and implementing the educational program of the social work students, also assume responsibility for grading of students, the collection of tuition fees and the assignment of credit according to the established policies of the University.
- 2. The field instruction internship will be selected for the educational value to the students._Bachelor of Social Work U ndergraduate Juniors will be at the field agency 7.5 hours per week for a minimum of 113 hours per semester and 250 hours per academic year: 225 hours in site-based placemen, 25 hours for professional development and social action. Bachelor of Social Work U ndergraduate Seniors will be at the field agency 11 hours per week for a minimum of 163 hours per semester and 350 hours per academic school year: 325 hours in site-based placement; 25 hours for professional development and social action. Master of Social Work students will be at the field agency: 15 hours per week for a minimum of 225 hours per semester in site-based placement hours and 475 hours total for the academic year: 450 hours in site-based placement; 25 hours for professional development and social action. The University calendar will be observed.
- 3. To assign a Faculty Supervisor of Field Internship to each student who will: monitor the students' field instruction performance, serve as a liaison between School, Agency, Agency Field Instructor, and Student, and confer a grade in field instruction.
- 4. To submit to FIELD AGENCY a listing of participating students and factual data as supplied by the student prior to the first day of field instruction.
- 5. That participating students will be covered for professional liability through a group malpractice insurance policy.
- 6. To assume responsibility for orienting students to the School's expectations in field instruction settings.
- 7. Indemnify and hold harmless FIELD AGENCY, its officers, directors, employees and students, of all claims, demands, causes of action and judgements arising out of injuries, including death of persons or property resulting in connection with this agreement from the negligent acts

or omissions of ADELPHI employees, agents or students.

B. FIELD AGENCY AGREES TO:

- 8. Accept Adelphi University School of Social Work students for social work field instruction experiences.
- 9. Supply mutually agreed upon supervision.
- 10. Design assignments in cooperation with the School of Social Work in educational planning in order to provide the student with maximum learning opportunities for the development of social work skills and for professional growth.
- 11. Make available appropriate office space for students in order to implement the educational program for social work students.
- 12. Follow the University calendar as it relates to holidays and vacation periods.
- 13. Assume responsibility for orienting students to agency policies, procedures and expectations of students in field instruction.
- 14. Indemnify and hold harmless ADELPHI, its officers, directors, employees and students, of all claims, demands, causes of action and judgements arising out of injuries, including death of persons or property resulting in connection with this agreement from the negligent acts or omissions of FIELD AGENCY employees or agents.

C. BOTH PARTIES AGREE AS FOLLOWS:

- 15. The parties acknowledge that many student educational records are protected by the Family Educational Rights and Privacy Act ("FERPA"), and that student permission must be obtained before releasing specific student data to anyone other than those associated with Adelphi University. Adelphi University agrees to provide guidance to the placement site with respect to complying with FERPA.
- 16. The parties agree to comply with all the federal, state, local and institutional laws, ordinances and rules applicable to Adelphi University, and specifically agree not to unlawfully discriminate against any individual on the basis of an individual's race, creed, color, national origin, ethnicity, sex, sexual orientation, disability, genetic predisposition or carrier status, age, religion, marital status, veteran status, or any other basis protected by applicable local, state or federal laws, and to comply with all anti-discriminatory laws and policies which Adelphi University promulgates and to which Adelphi University is subject.
- 17. To extent applicable, both parties shall comply with all relevant New York State and Federal confidentiality laws including the Health Insurance Portability and Accountability Act of 1996 (HIPAA). Where applicable, both parties shall provide staff, students and all interested personnel with training in the requirements of the privacy and security provisions of HIPAA and advise them of the importance of complying with all procedures relative to HIPAA.
- 18. Any notices required to be given under this Agreement shall be sent to the addresses listed in the first paragraph. If the notice is sent to ADELPHI UNVERSITY, it shall be directed to the Vice President of Finance at One South Avenue, Levermore 201, Garden City, New York 11530. If sent to FACILITY, it shall be sent to the address noted and directed to the attention of the signatory.
- 19. Governing Law and Venue. This Agreement shall be governed by, interpreted, construed, and enforced under the laws of the State of New York, without regard to the principles of conflicts of laws. Any claims under this Agreement must be brought in a court of competent jurisdiction located within the State of New York or, at the University's sole discretion, may be referred to the American Arbitration Association for arbitration proceedings.

- 20. Electronic Signatures and Transmissions This Agreement may be transmitted in electronic format and shall not be denied legal effect because it was formed or transmitted, in whole or in part, by electronic means. An electronic, digital or electronically transmitted signature (collectively, "Electronic Signature") will be deemed an acceptable original for purposes of consummating this Agreement and binding the party providing such Electronic Signature.
- 21. Entire Agreement This constitutes the entire agreement between the parties with respect to the subject matter and no statement, promise, or inducement made by either party or agent of either party that is not contained in this written Agreement shall be valid or binding. This Agreement may not be enlarged, modified or altered except in writing signed by both parties and endorsed thereon. This Agreement shall be construed without regard to any presumption or other rule requiring construction against the party who caused this Agreement to be drafted.




