NO AMENDMENTS TO THE AGENDA

MINUTES: January 12, 2023 minutes approved. Motioned by Charmian Foster and 2nd by Jill Kissick-Castro, passes unanimously.

APPOINTMENTS & RESIGNATIONS: Judd Karlman – appointed to Head of Information Services (Librarian III). Motioned by Sarah Glose and 2nd by Peter DeWind, passes unanimously.

With this appointment Sherry Kowalski is very happy to be able to move fully into her new position as Assistant Library Director II. The board celebrates this.

NEW BUSINESS:

• The Nominating Committee, represented by Jill Kissick-Castro, introduces Al Buyck and Vikki Collazo as prospective trustees.

Al is the Interim Superintendent of Harpursville CSD after having recently retired as the District Superintendent of Broome-Tioga BOCES. He has served on the United Way of Broome County, along with many other boards, and currently serves on the board for WSKG Public Media. In his role as District Superintendent he served as a non-voting, ex-officio member of the BCPL Board of Trustees.

Vikki is the Director Youth Employment/Volunteer Engagement at the Children's Home of the Wyoming Conference, and formerly worked at both the Binghamton Rescue Mission in Donor Relations and at the Greater Binghamton Chamber of Commerce as the Manager of Membership & Marketing. She is the Past Club President of the Rotary Club of Binghamton and is involved with VAST- Volunteer Association of the Southern Tier and many other community projects.

Jill Kissick-Castro moves to approve Al Buyck and Vikki Collazo as members of the Broome County Library Board of Trustees, 2nd by Charmian Foster, passes unanimously.

 2023 Committee Assignments: Charmian Foster, as chairperson of the Nominating Committee, suggested that the ad-hoc Facilities Use/Meeting Rooms committee be removed, to be replaced by a Policy Review Committee. Said committee would be in charge of updating policies and raising awareness of policies to the Board. Charmian will send committee descriptions out to the Board. Please take the time to review.

- Reminder about Trustee responsibility to attend two hours of continuing education related to the Library. Please record and submit to JoAnne Hanrahan when complete.
- Josias and Sherry are going to Albany on February 28th with other Four County Library System folks for Library Advocacy Day.

Governor Hochul has cut library funding in her upcoming budget. It is important for all of us to advocate for the library. Peter DeWind suggests putting this information on the Library website and social media. Sarah Glose mentions that we have testimonials about why the Library is important to community members from the appeal last year that might be of use.

- The Library purchased the additional carpet pieces from Rug Fair.
- The Bylaws read:

If any member of the Board of Trustees fails to attend three (3) consecutive regularly scheduled meetings, the Executive Committee shall ascertain the reasons for such absences and then recommend to the Board whether such member should continue with or be expelled from the Board.

Kate Miller-Corcoran asked for a clarification of this at the January board meeting and a clarification of what the procedure is should a board member need to take an extended absence.

Jennifer Church, attorney from the County, reports that there does not need to be a hearing. She also reminded the board that the ByLaws were written for their protection.

So that all know, please make the Board President and Library Director aware of the expected length of your extended absence and whether or not you would like to be contacted during that time.

• The Friends of the Broome County Public Library donates over \$40,000 to programming such as summer reading, free yoga and make and take crafts.

OLD BUSINESS

• 2023 Holiday Schedule needs to be revised to reflect October 9th as the observed day for Indigenous People's Day.

Motion to revise the date from the 10th to the 9th made by Jill Kissick-Castro, 2nd by Sarah Glose, passes unanimously.

REPORTS

Committee Reports:

Strategic Planning Committee: Survey is out on the website, facebook, and will be available in person, optionally, at Library programming and at Circulation and Youth Services. Dale Ketcham will be at the library on Saturday during the Friends' Book Sale.

Finance Committee: 2022 Final budget numbers look great. 99% of payroll was used. The Book budget was so close, each one just under budget. WELL DONE! Also, the 2021 invoice was paid by the City of Binghamton.

OTHER

Security is back to full staffing.

A Staff Safety Advisory group has been formed to create internal guidance for staff in how they should respond to harassment by patrons. There will be a half day workshop on setting boundaries.

Harm Reduction in Public Libraries

What is harm reduction?

What does this look like?

- Needle/syringe drop boxes
- Clean needle/syringe access programs
- Safe use spaces
- Overdose prevention through tactics like Naloxone and fentanyl testing strips
- Information on safe drug use
- Services that help to better housing, health care, mental health services, food access, & overall community well-being

- A public health approach that provides a set of strategies and practices to reduce the negative consequences of drug use
- Focuses on positive change and on providing services and resources.
- The overall goal is to improve the wellbeing of individuals and communities. While part of this can include providing information and resources on sobriety and treatment, the goal is to help people stay safe, even if they choose to use drugs.

Why are libraries involved in harm reducation?

What can this look like in public libraries?

- Needle/syringe drop boxes
- Naloxone training for staff and/or community members
- Information on safe drug use through presentations, tabling, and/or pamphlets
- Working with court-ordered drug programs to provide information & resources

- Opioid use & opioid overdoses are on a rise, and these occur often in public spaces, such as public libraries.
- Over 95% of Americans have access to a public library, and they are already used for countless reasons.
- Public libraries can be a core part of public health efforts, and community services because of their access, use, and community ties.
- Harm reduction meets a need that is already present in libraries.
- Public libraries are becoming community centers, and this is an additional step in helping build stronger, healthier communities.

What is BCPL doing already?

- --- Needle drop boxes in the bathrooms
 - Peer support program
 - Information on Naloxone available at the Reference Desk
 - A working relationship with the Health Department & community groups involved in this work
 - Security, and some staff, who are trained to administer Naloxone

Other ways BCPL is involved in public health initiatives, besides harm reduction

- Exercise & mindfulness classes, such as yoga & reiki
- Free menstrual products
- · Free safe sex materials & information
- Vaccine clinics provided by the Department of Health
- Community groups coming in to provide services & programs, such as VINES providing talks on gardening & Senior Services providing talks on signing up for Medicaid
- Providing accurate and timely information & resources
- Offering free coffee & tea through Peer Support
- Teen programs that allow a safe space to gather
- A variety of programs that encourage socialization & community interactions
- A temperature-controlled building that offers a safe, free, accessible space to spend time, as well as free bathrooms & drinking water
- Free COVID tests & masks
- Free access to computers & internet

How do we want to continue these efforts?

Harm reduction tactics

- Continuation of the peer support program
- Voluntary staff & community Naloxone training
- Fentanyl strips available to the public
- Increased information on drugs & their effects, as well as safe drug use, provided through community partners

Other public health tactics

- Increased exercise classes
- Computer classes
- Farm-to-table program
- Continued work with community partners, such as the Department of Health & VINES
- STI testing provided by a community partner
- Increased information on public health topics, such as healthy eating & mental health services
- Further staff training on public health topics, such as working with diverse communities



MEMORANDUM OF UNDERSTANDING

This MOU is by and between the Agencies listed below:

Greater Opportunities for Broome and Chenango, Inc.
 Broome County Public Library

Performance under this MOU shall commence upon the signing of this agreement and this MOU shall remain in effect until such time as one or more of the signatures formally terminate their participation in the MOU by written notice to all current signatories. This MOU commits the parties to refer applicants for eligible grants and programs to each of the other signatory's agency whenever necessary. Each party will notify the other of programming and funding availability and/or requests for new applications for each signatory provided there is space available and the request is received prior to the monthly deadline for publication. In addition, the parties specifically agree to:

- 1. Refer clientele to each of the signatory's respective agency whenever a program and/or funding availability that cannot be filled by the current waiting list.
- 2. Refer current clientele to available programming and/or funding availability with each other whenever their client's needs may be met by one or more of the other signatories to this MOU. Referral of applicants will be done on a voluntary basis only, with the concurrence of the applicant.
- 3. Determine each applicant referred to their agency for program eligibility. The referral agency is not responsible for determining an applicant's eligibility for any program of the other signatories to this MOU. Program eligibility determinations are the sole responsibility of the agency.
- 4. Consider each applicant referred to them using the same rules and regulations governing eligibility for the particular project and said applicants will not be given preference or special treatment in the signatory's selection process.
- 5. Safeguard the confidentiality of any information supplied by the signatories to this agreement about the individual applicants being referred under this MOU.
